

- Different perspective,


STATISTICS ABOUT OFFICE AND IT

Regular work-at-home, among the non-self-employed population, has grown by 140% since 2005, nearly 10x faster than the rest of the workforce or the self-employed (global workplace analytics)

Of 44,008 respondents in a Stack Overflow survey, 35.1% said they work remotely at least a few days per month. 28.8% of respondents work from home more frequently than that. The highest job satisfaction was reported by developers who are completely, or almost completely remote.

56% of startups worldwide have outsourced their work, contributing to the demand for remote workers

2 out of 3 respondents in a survey conducted by Polycom Inc said they are more productive working remotely than when they worked




OPURTUNITY FOR THE HISTORIC CENTER



Many historical buildings are already demolished in the past few year. In order to keep historical vibe of Cesis it is necessary to preserve these buildings as much as possible.

Concept of work tourism promotes using these buildings even in bad shape as temporary place for offices for people who enjoy working remotely. These people can see these old buildings as additional extra, charecter to their travel and work experience.



OWNER



CITY ORGANIZATION

Likely public organisation funded by city, which plans the processes around the buildings given for them to manage.



LESSOR

Depending on size and profit level pays rent and/ or fixes the building



NEW OWNER

Building is sold when buyer is found with terms of finishing the repairs, first hand to lessor or previous owner. Price need to match atleast that amount what city funded

USAGE OF HISTORIC BUILDINGS

Work toursism can work as a tool to revitalize buildings in Cesis that currently are degrading city. Newborn business may not be so picky about the quality of workplace and building is benefiting from active users in them. Accesable work space can work as a tool to attract new bussines from neighboring cities and can serve the reason to start it in Cesis even while living in another city.

These business that will be attracted will help to preserve building while it is decided what to do next.

Using existing buildings is environmentally friendly act as the main structure is already build which creation usually is cause for most CO2 emissions in building process

PROCESS FOR THE BUILDING

Historic buildings are the thing that brings many vissitors to Cesis, they enrich the city with romantic architecture and historical feel. If the owner of the property in the historical center cannot take care of the property, city needs to have action plan. It is clear that city cannot fund restoration for private owners, but there are examples from what cities can learn, how to preserve buildings with help of lessors. Examples ofcourse varies, there are cities that take ownership over these buildings, and there are organisations that help to maintain buildings while they are preapearing for reconstruction. It is important for Cesis their solution to this issue. Version where city or it's funded organisation take over buildings that are leased and slowly repaired is offered. Many old buildings have broken some things that is damaging the building further, like drainage system, if that is fixed, the building can last much longer, and it can be fixed in slow manier. In the procces of maintaining it and renting it out new owner can be found, if new company choose to start their bussines there it is possible that they can be the future owners of this place.


WORK IN CESIS- LONG TERM
